

# Federal Law Requires First Responders to Have Specialized Chemical Spill Response Training

## Chemical Spill Response Training and Certification to Meet 29 CFR 1910.120(q)

In order to properly respond to chemicals spills which may occur on the job, first responders must receive 8 hours of documented specialized training from an authorized source in order to prove "awareness level competency". At least one person from each company must receive this training. Failure to have certified personnel on staff may result in spills handled by hazmat crews and possible fines of up to \$5,000.00 per minute while hazmat is in route. You may not be able to use any spill control kits on your vehicle without proof of completion of this course.
